

## Primary Maternity Services Amendment Notice 2019

Pursuant to section 88 of the New Zealand Public Health and Disability Act 2000, the Crown issues the following notice.

### Notice

#### 1. Title—

(1) This notice is the Primary Maternity Services Amendment Notice 2019.

(2) In this notice, the Primary Maternity Services Notice 2007, which was published as a Supplement to the New Zealand Gazette, 13 April 2007, No. 41, page 1025, and became effective from 1 July 2007, is called the **principal notice**.

**2. Commencement**— This notice comes into force on 1 July 2019.

**3. Amendment to Schedule 1**— The principal notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this notice.

**4. Revocation**— The following notice is revoked:

- a. The Primary Maternity Services Amendment Notice 2018, which was published in New Zealand Gazette, 28 June 2018, Notice Number 2018-go3087. and became effective from 1 July 2018;
