



















Personal protective equipment (PPE) requirement in Maternity settings for prevention of COVID-19

Where possible women should be telephone screened prior to any face to face visit or entry to the maternity unit.

This is a guide on recommended PPE. It is expected that clinicians involved in care will use appropriate clinical judgement on PPE required.

| For women who do not have COVID-19, and are not in 14-day isolation; standard precautions are still required as per normal practice. |  Hand Hygiene ‡ |  Surgical Mask |  N95/ P2 Mask |  Eye Protection* |  Gloves |  Fluid Resistant Gown or Plastic apron |
