Increase to primary maternity fees for rural and complex care modules

On 22 September 2020 the Director-General of Health approved publication of the amended Primary Maternity Service Notice 2007.

The draft amendment increases fees for 12 modules of care for rural and complex cases. These increases recognise the additional time some LMCs spend travelling to provide services to women in rural locations, and the care LMCs provide for complex cases in the third trimester. These uplifts have been put in place now to recognise the work while the process of consulting on the wider changes Notice takes place. It is expected that these will be superseded by changes made as a result of that consultation process. More information about that consultation can be found on the Ministry's website (www. health.govt.nz).

Please refer to Appendix 1 for the list of modules affected and for the full draft Amendment Notice and new draft fee schedule.

The Ministry will publish the final Amendment Notice relating to these uplifts in the New Zealand Gazette and on the Ministry's website on 28 September 2020.

There are no changes to other parts of the Primary Maternity Service Notice 2007 at this stage. Parts A, B, C, D and Schedule 2 of the Notice remain the same and continues to be applicable.

This increase is separate from and in addition to the 2.18 percent fee increase for all LMC and Non-LMC modules that came into effect from 1 July 2020.

The application of the new fees to claims is determined by the date of service. The date of service is the last date of the period to which the module of service applies. Claims with service dates on or after 1 July 2020 will be paid the increased fees as per the Amendment Notice.

Notice

1. Title—

(1) This notice is the Primary Maternity Services Amendment Notice (No. 2) 2020.
(2) This notice amends the Primary Maternity Services Notice 2007 ("Principal Notice"), published in the New Zealand Gazette, 13 April 2007, No. 41, page 1025.

2. Commencement— This notice comes into force on 1 October 2020.

3. Amendment to Schedule 1— The Principal Notice is amended by revoking Schedule 1 and substituting the new Schedule 1 set out in the Schedule to this notice.

- 4. Revocation— The following notice is revoked:
 - a. The Primary Maternity Services Amendment Notice 2020, which was published in the *New Zealand Gazette*, 29 June 2020, Notice Number **2020-go2803** and became effective from 1 July 2020.

5. Implementation date— For the purposes of clause A12 of the Principal Notice, the implementation date for this notice is 1 July 2020.
